Exhibiting Conditions and Rules

Please Read and Sign on the back of the application

- Booth spaces will be issued on first come, first serve basis. Spaces are outdoors on asphalt, in the historic downtown shopping area. Tents are required for Street Fair exhibitors (setup weights only).
- Roaming security will be available during the show hours, but each exhibitor is responsible for his/her own items and space. Security will be on duty only Saturday evening from 5:00 p.m to Sunday morning at 9:30 a.m. Exhibitors leave merchandise at their own risk.
- Pinal County Health Permits are required for food vendors and all vendors are responsible for collecting, reporting and paying your own sales tax. Include your Arizona State license number on this application. The State requires us to furnish this information.
- **Check in prior to setting up.** Check in Friday night after 5:30 p.m. or before 8:00 a.m. on Saturday. Prepaid exhibitors arriving after **8:00 a.m. Mountain Standard Time** will be assigned space only if available. No refunds will be given.
- The street fair area must be cleared of all vehicles by 9:00 a.m. daily.
- Tear down is not to be started before closing of fair on Sunday.
- A registered exhibitor must be on duty in the booth at all times of the fair operation.
- No pets are allowed at booth sites.
- Personal conduct, rule violations, complaints from patrons as to misconduct during the fair may be grounds for removal by fair officials.
- Any reports of orders taken and not fulfilled by a exhibitor will deem them to be removed from future events and possible charges filed.
- A limited amount of commercial items will be considered based on their uniqueness.
- No refunds due to exhibitor cancellation after January 2, 2008.
- We are a not-for-profit organization. The event will be held rain or shine.
